General Information and Test Rules

Drawing for Acceptance into a test: The drawing will be held at Arby's, Eureka, MO on October 31, 2024 at 7 p.m. to determine which entrants will participate in the tests and the position of excess entrants on the Alternate List. There will be two drawings for each test - first draw will be for past test workers. Preference is given to entrants who have not earned the title for class entered. All entrants will be advised by email, if such address has been provided, on November 1, 2024 otherwise you will be notified by USPS mail.

Drawing for running order of tracks:

There are 3 tracks and 1 alternate for the Tracking Dog Urban Test. The draw for the running order will be held at 7:30 am and the first track will be run when the judges indicate. There are 3 tracks and 1 alternate for the Tracking Dog. The draw for the running order will be held at 10:00 am and the first track will be run when the judges indicate. **NOTE:** If the limit for entries in not reached in one test and the limit is exceeded in the other tests, the *#* of tracks will be exchanged up to the limit set by the AKC Tracking Regulations.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name.
